

Application for No Visa Required (NVR) endorsement by Mail Service

1. Printed copy of duly filled-in No Visa Required (NVR) application form available at <https://florida.mofa.gov.bd>;
2. Original valid US passport with photocopy of the same (**Photo page**);
3. Photocopy of any court or official order in case of a name change. However, in case of women adding their husband's name as suffix, please attach a photocopy of marriage certificate;
4. **For applicants born in Bangladesh, following documents are required:**
 - a) Previously issued original NVR on US passport, OR
 - b) One of the following documents:
 - Photocopy of valid/expired Bangladesh MRP/E-Passport (bio page)
 - 17-digit Bangladesh Birth Registration certificate (verifiable online)
 - Dual Nationality Certificate
 - National ID of Bangladesh
 - Citizenship certificate issued by Union Parishad/City Corporation of Bangladesh
5. **For applicants born in the USA, the following documents are required:**
 - a) Previously issued original NVR on US passport, OR
 - b) One of the following documents:
 - Photocopy of US Birth Certificate (that contains name of parents), and
 - Photocopy of valid/expired MRP/E-Passport/NID/17-digit Bangladesh Birth Registration certificate (verifiable online)/Dual Nationality Certificate of either parents
6. **For foreign spouse of Bangladeshi citizen or Bangladesh origin US citizen, following documents are required:**
 - a) Previously issued original NVR on US passport and photocopy of marriage certificate.
 - b) Photocopy of MRP/E-Passport/NID/17-digit Bangladesh Birth Registration certificate (verifiable online)/Dual Nationality Certificate of Bangladeshi/Bangladeshi origin spouse.
 - c) Notarized affidavit/declaration on the unbroken status of marriage (sample enclosed).
7. Recent passport size (2-inch X 2-inch) photo with white background and name on the back (One copy);
8. Payment through Credit Card (3% merchant fees applicable) or Money Order/Postal Order/ Bank Certified Cheque of **\$ 88.00** (including surcharge) in favor of '**Consulate General of Bangladesh Miami**'. Debit Card/Cash/Personal Cheque will not be accepted. In case of more than one application submitted together, separate payment has to be made for each applicant;
9. The applicant must provide a self-addressed **return envelope** (prepaid/with appropriate postage stamps) and tracking number of Priority/Express Mail of **USPS only**. Applicants belonging to same mailing address can send their applications together in one envelope and enclose one return envelope;

11. After the application package is received, the processing time is 7 (seven) working days. However, it may vary in some cases due to caseloads. The Consulate may request, if necessary, an in-person interview and/or submission of additional documents;
12. The Consulate General of Bangladesh has the full right to accept or reject any application and return the application without endorsing NVR if the application is incomplete;
13. Please note that the area of jurisdiction of this Mission covers eight US States i.e., **Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, South Carolina, and Tennessee**.
