

SUPT Avatar Modifier Tip Sheet

For Services on or After July 1, 2019

Sacramento County Alcohol and Drug Providers are required to use new billing requirements to claim their services to Department of Health Care Services for any DMC Organized Delivery System (ODS) services on or after July 1, 2019. Each claim should include any necessary modifiers. The U code modifiers will need to be used to establish the level of care. The H code modifiers will need to be used to distinguish between Narcotic Treatment Program (NTP) and non-NTP, between youth and adult, as well as between perinatal and non-perinatal. The Medication Assisted Treatment (MAT) claims also need to include the National Drug Code for the medications that are administered in the NTP setting.

1. Most ADS service codes have hardcoded modifiers set up by the Billing Team. Case Management and Physician Consultation are 2 examples of exceptions where the provider will need to add the appropriate modifiers. For Services on or After July 1, 2019

- **2.** Modifiers are case sensitive and must be entered in the following format in order to avoid service denial.
 - a. Do not use lower-case letters or add spaces. A comma is needed between each modifier. Ex. U7,HA
- **3.** Enter, and/or edit a service to include a modifier anytime the hardcoded modifiers are not enough to distinguish between the various ODS services that are available.
 - **a.** Remember when adding additional modifiers by editing the services you must include the hardcoded modifier.
- **4.** Only use the modifiers from the ODS Code List for services provided on or after July 1, 2019.
- 5. When entering a service, the hardcoded modifier will not auto-populate the Client Charge Input screen. Please check the Avatar ODS Code List to determine if the service you are entering is hardcoded, and what additional modifiers are available.
 - **a.** For example, in the Client Charge Input screen below for an ODF Intake and Assessment (Z500), the service is hardcoded with the U7 modifier, however, it will not populate at this point. When the service has been saved, and the "Services with Modifiers" report run, it will then show the U7 hardcoded modifier.

- **6.** DMC providers must run the report listed below for each month of service being submitted to complete quality assurance of their service modifiers.
 - a. Services with Modifiers Report This report will give you the Actual Level of Care the client will be receiving (ASAM LOC), and let you know if the client has been identified as being pregnant in Avatar. Use that information to determine if the service requires additional modifiers.
 - **b.** This report and other beneficial reports can be found in a monthly billing reminder email sent out by <u>Avatar-Fiscal@saccounty.net</u>.

Below are examples of what the report looks like and steps on correcting modifier errors:

Example #1: NTP Services were entered with the duplicate service modifier. As noted above, this modifier is no longer needed. If found, provider would first check that the service is still open status, and if so, they would edit service and remove the HG59 from the modifier field. Once they save, the system will revert back to the original hardcoded modifiers. If the service is closed status, please contact <u>Avatar-Fiscal@saccounty.net</u> for support.

Example #2: Case Management Services were entered, but a modifier was not entered. Provider would first check that the service is still open status, and if so, go to the edit service screen, and enter the appropriate modifiers for this service. Please refer to the current Avatar ODS Service Code list for modifiers allowed with this service. If the service is closed status, please contact <u>Avatar-Fiscal@saccounty.net</u> for support.

Example #3: An additional modifier was added to ODF Group Services. Although there are no spaces, and the letters are upper case, there is no comma between the two modifiers. Provider would first check that the service is still open status, and if so, go to edit service screen, and add a comma so that it looked like this: "U7,HA". If the service is closed status, please contact <u>Avatar-Fiscal@saccounty.net</u> for support.
