Quick Reference Guide: How to Obtain Medical Marijuana

STEP 1: VISIT A PHYSICIAN WHO IS CERTIFIED TO RECOMMEND MEDICAL MARIJUANA

- The first step to become a medical marijuana patient is to establish and maintain a physician-patient relationship with a physician holding an active certificate to recommend (CTR) issued by the State Medical Board of Ohio.
- To locate a CTR physician, click here.
- An in-person or telemedicine visit with a certified physician is required at least once per year.
- The physician will determine if you have a <u>qualifying condition</u> to be a medical marijuana patient.
- If the physician determines you have a qualifying condition and recommends medical marijuana for you, the physician will create your profile in the Patient & Caregiver Registry, along with their recommendation.
 - Your physician may also make specific product recommendations and refill specifications for you. The physician may recommend up to a <u>90-day supply</u> of medical marijuana with three refills (totaling 360 days).
 - If you wish to register with <u>indigent or veteran status</u>, the physician must indicate this when creating your profile in the Patient & Caregiver Registry.
- The physician will need the patient's valid Ohio driver's license, a valid Ohio identification card issued by the Ohio bureau of motor vehicles (BMV), or <u>another form of identification</u> <u>approved by the MMCP</u> to demonstrate residency.
- A registered caregiver may possess and administer medical marijuana to patients with whom the caregiver's registration is associated. The certified physician will need similar identification from a caregiver to establish their profile in the Patient Registry.

STEP 2: GET REGISTERED

- Once a recommending physician has entered a patient or caregiver into the registry, the patient/caregiver will receive an email prompting them to login to their profile in the <u>Patient</u> <u>Registry</u>. In the registry, complete your application and pay the fee.

- The annual cost of a medical marijuana registration is \$50 for patients and \$25 for caregivers.
 - Patients who qualify for indigent or veteran status may be eligible for fee reductions. For more information, <u>click here</u>.

STEP 3: FIND A DISPENSARY

- After receiving your Patient & Caregiver Registry card, you may purchase medical marijuana from a licensed Ohio dispensary.

- Dispensary staff will counsel you on the appropriate type and dose of product for your condition.
- Only patients with an active registry card, an active recommendation, and their associated government-issued ID can purchase medical marijuana.
